- 2. Unretouched proofs are never presented or sold to clients. The Supplier will handpick the events' best images. Each of these images will be retouched and enhanced based on Photographer's artistic vision. Photographer reserves the right to edit and release only those deemed creditable as professional in quality and within Photographer's artistic standards. The Clients' final Gallery images will be online and available for download for 1 months from the delivery date. The Supplier has no further obligation towards image manipulation once the final product has been delivered.
- 3. The Photographer will document the events in a candid manner and take formal portraits as necessary. The client should provide a full list of formal family photographs required including names and relationship to the client. Prior to or during the event, the Client may inform the photographer of subjects which they would like photographed, but the final content of the images is at the discretion of the Photographer.
- 4. The Client will ensure that the guests at the event do not interfere with the Photographers' work. The Supplier is the sole photographer for said event.
- 5. It is the sole responsibility of the Client to secure permission of the church, synagogue or other venue of the wedding for the Supplier to photograph the ceremony/event. The Client shall insure the placement of the bridal party, the officiant(s) and the altar decorations so as to not obscure the view of the bride and groom. The Supplier will abide by the rules of the church/synagogue in regards to camera placement at the ceremony. Many cities, counties, state agencies and private venues/businesses are charging a photography permit fee. The Client is responsible for the payment of such fee. In the event Clients fail or refuse to pay for any such permit fee, Client is responsible for any and all related costs or fines if applicable.
- 6. Processed digital photos shall be delivered to the Client on USB or online digital download. Delivery of photographs to the Client is estimated to be, but not limited to, 6-8 weeks after the date of the event. The Supplier will make every effort to deliver photographs within the period stated above. In the event that the photographs are delivered outside the period stated above due to unforeseeable circumstances, The Supplier is not liable to refund any payments made by the Client.
- 7. It is the Clients' option to provide the photographers and assistant(s) a hot meal for events of 5 hours or longer. If a hot meal is not provided, it is understood that the Supplier and assistant(s) will leave the event for one hour to purchase a meal. The Supplier is not responsible for any photos that may be missed while obtaining a meal.
- 8. For locations 3 or more hours away, the Client must provide a one to two night hotel stay in a non-smoking room. The Supplier will also charge a vehicle expense based on the standard mileage rate per mile for the amount of miles to and from the location of the clients' event to cover gas, mileage, tolls, etc. These fees must be paid in advance of the event.
- 9. Model Release: The signing of this agreement by the Clients constitutes a commercial model release by the Clients to the Supplier. The Supplier will have the right to make

reproductions include but not limited to website, portfolio samples, self-promotion, magazine editorial use, advertisement/marketing and professional competition without further release. The Supplier will not make reproductions for other commercial use without first obtaining the written permission of the Clients. Client waives the right of tort of invasion of privacy due to any reproductions.

10. Payment -The Client's payment to the Photographer shall be as follows:

- 13. If the Photographer is unable to perform due to fire or other casualty, strike, or other cause beyond the control of the parties, or due to the Photographer's illness or injury, then the Photographer shall return the deposit to the Client but shall have no further liability with respect to this agreement. This limitation on liability shall also apply in the event that images are lost through equipment malfunction, lost in the mail or otherwise lost or damaged without fault on the part of the Photographer. In the event that the Photographer fails to perform for any other reason, the Photographer shall not be liable for any amount in excess of the Photographer's fee.
- 14. Upon signature, the Supplier reserves the time and date agreed upon. For this reason, all reservation fees are non-refundable, even if the wedding date is changed or canceled for any reason. There shall be NO refund of any payment made. Client is aware that the photographer is blocking off the particular date in question therefore turning away any other potential work on that date therefore there is no cancellation and no refund permitted. If final payment is not received, Tire Swing Photography will not be expected to attend said event.
- 15. This Agreement constitutes the entire understanding between the parties. Its terms can be modified only by an instrument in writing signed by both parties.
